conduct and management of such business and do all such acts, deeds and things as they may consider necessary or expedient and in particular to appoint and at their discretion remove or suspend such agents, managers, secretaries, officers, clerks, servants and any other person or persons for permanent, temporary or special services as they may from time to time think fit and remunerate them or any of them either with salary or with share of profits or income arising out of such business and to require security on such business and in such accounts as they may in their absolute discretion think fit and proper.
