



In pursuance of Government Order No. 6869/SME dated 22.4.2010 the No objection Certificate issued in favour of English Medium School vide Directorate Order No. 8250 dated 6.2.2010, No. 17224 dated 31.3.2010 and No. 18876 dated 15.4.2010 is hereby modified and the revised No objection Certificate is granted conditionally for a period as mentioned against each in favour of following English Medium Schools for opening of un-aided Secondary Schools up to Class-X for the purpose of obtaining affiliation from the CBSE/ICSE subject to the following terms & conditions.

1. The "No Objection Certificate" now issued shall be subject to the terms and conditions as prescribed in the G.O.No.30720-SME dated 23.9.1996.
2. The land is to be recorded in the name of institution and copy of the record of the rights to be furnished by the authority of the institutions within one year from the date of issue of the order.
3. Medium of instruction in the School shall be English but Oriya shall be taught as a subject to all pupils in the institution compulsory.
4. The school shall be open for inspection by the inspection team.
5. No financial assistance and grant-in-aid (both recurring and Non-recurring) will be claimed by the institution from the Govt. at any point of time for meeting the salary cost and its component towards teaching and Non-teaching staff appointed by the managing committee.
6. The M.C. of School will not shift the present location of the school without prior approval of Director, Secondary Education, Orissa.
7. The High Power committee shall review the N.O.C. granted to the institution concerned in the next HPC after elapse of one year and shall withdraw the same if the terms and conditions contained in the G.O.No.30720/SME dated 23.9.96 is violated at any time.
8. The Managing Committee shall be constituted in accordance with the Section-7 of the Orissa Education Act-1969.
9. All the Schools those are granted conditional NOC will have to submit an affidavit to the effect that :
  - A) Their staff are being paid at par with their counterparts in Government Schools.
  - B) Oriya is being taught as a compulsory subject.
  - C) All the untrained teachers will be trained/substituted by trained teachers within the stipulated period.
  - D) The management of the Schools will construct their own building on their own land within 3 years.


